1. This Act may be called the Mumbai Municipal Corporation and Short title. Maharashtra Municipal Corporations (Amendment) Act, 2023.

STATEMENT OF OBJECTS AND REASONS.

Clause (b) of sub-section (1) of section 5 of the Mumbai Municipal Corporation Act (III of 1888) provides that the Corporation shall consist of five nominated councillors having special knowledge or experience in the Municipal Administration and clause (b) of sub-section (2) of section 5 of the Maharashtra Municipal Corporations Act (LIX of 1949) provides that each Corporation shall consist of such number of nominated councillors not exceeding five having special knowledge or experience in the Municipal Administration.

2. A person having knowledge and experience in the Municipal Administration is nominated as a councillor for more effective administration of municipal corporations in the State. With a view to qualitatively improve the functioning of the corporations by utilizing the knowledge and experience of the members so nominated, the Government considers it expedient to increase the number of nominated members from five to ten, in the Municipal Corporation of Brihan Mumbai; and from not exceeding five to not exceeding ten per cent. of the total number of elected Councillors or ten, whichever is less in the other Municipal Corporations in the State. It is, therefore, proposed to amend section 5(1)(b) of the Mumbai Municipal Corporation Act and section 5(2)(b) of the Maharashtra Municipal Corporations Act, suitably.

3. The Bill seeks to achieve the above objectives.
